Dear Democratic Party Leaders and Public Officials,

The horrifying news of Gov. Michelle Lujan Grisham's hush money payments from her campaign account to one of her sexual accusers, James Hallinan, to the tune of \$150,000, should shock every single New Mexican — regardless of party affiliation. Lujan Grisham is also accused of groping another man, Eddie Dehart, during the time she was the New Mexico Secretary of Health in 2005.

Sexual abuse should never be okay and must always be taken seriously, especially when committed by public leaders. Lujan Grisham has repeatedly betrayed her positions of power and desecrated one of the chief rules of the *Governmental Conduct Act*, that "Legislators and public officers and employees shall conduct themselves in a manner that justifies the confidence placed in them by the people, at all times maintaining the integrity and discharging ethically the high responsibilities of public service."

Alleged groping and sexual assault hush-money payments to one's accusers betray the confidence the voters of New Mexico placed in Michelle Lujan Grisham when she served in the Cabinet, as a member of Congress, and as governor.

However, despite the depravity of Lujan Grisham's alleged actions and subsequent payoffs, most New Mexico public officials and Democratic Party leaders have remained silent — including every top-ranking Democrat in the state, from party chair to lieutenant governor.

Therefore, on behalf of the tens of thousands of readers of the *Piñon Post*, who care about the rule of law and holding accountable those who betray the public's trust, as evidenced by thousands signing our <u>petition</u> demanding the governor resign over the groping conflict, we call on all high-ranking public officials and party leaders (starting by those listed below) to denounce Michelle Lujan Grisham's alleged serial groping. Otherwise, these individuals are complicit in the denial of these sexual assault whistleblowers' lived experiences — perpetuating a culture of sexual violence.
