

RESOLUTION R-06-022 PURCHASE OF REAL PROPERTY FOR ROSWELL ENERGY LIBRARY

WHEREAS, Chaves County was awarded funds in 2005 by the State of New Mexico for a building to house the Energy Library; and

WHEREAS, the members of the Energy Library Board have identified two properties on Main Street, 312 N. Main and 318 N. Main, which can serve as the Energy Library; and

WHEREAS, Chaves County, as fiscal agent for the Energy Library, has negotiated with the owners of these properties and we are prepared to purchase these properties; and

WHEREAS, the property located at 312 N. Main is approximately 3,920 square feet with a purchase price of \$150,000.00; and

WHEREAS, the property located at 318 N. Main is approximately 3,145 square feet with a purchase price of \$85,500.00; and

WHEREAS, staff is requesting authorization to proceed with the purchase of these two properties, and in addition, seeking authorization for the Chaves County Commission Chairman to sign all documents associated with the purchase of these properties.

NOW THEREFORE, it is hereby resolved by the Board of Chaves County Commissioners that County staff is hereby authorized to proceed with the purchase of the property located at 312 N. Main and 318 N. Main, at the above stated purchase prices, for use by the Energy Library.

IT IS HEREBY FURTHER RESOLVED by the Board of Chaves County Commissioners that the Chairman of the Chaves County Board of Commissioners is authorized to sign all documents, agreements, etc., associated with the purchase of the above-stated properties.
